

RESOLUTION NO. 2018-10

AN RESOLUTION
ADOPTING A NEW FEE SCHEDULE FOR ZONING PERMITS
AND DECLARING AN EMERGENCY

Whereas, Section 1117.06 of the Codified Ordinances of the Village of New London specifies that this Council shall set the fee schedule for zoning permits, Now, Therefore,

BE IT RESOLVED BY THE COUNCIL OF THE VILLAGE OF NEW LONDON, HURON COUNTY, OHIO, AS FOLLOWS

Section 1. That there is hereby adopted a new fee schedule for Zoning Permits issued by the Village of New London, which shall be as follows:

Section 2. That this Resolution is hereby declared to be an emergency measure necessary for the immediate preservation of the public peace, health, or safety, and for the welfare of the citizens of the Village, and for the further reason that it is necessary that this measure become effective at the earliest possible time, so that the increased fees can be implemented and received at the earliest possible time, and that, provided it receives the majority vote of two-thirds or more of those elected to Council, this Resolution shall therefore take effect and be in force immediately from and after its passage, and otherwise it shall take effect at the earliest period allowed by law.
