

ORDINANCE NO. 2020 - 06

AN ORDINANCE ADOPTING THE 2020 PERMANENT ANNUAL APPROPRIATIONS
FOR CURRENT AND OTHER EXPENDITURES FOR THE OPERATION OF THE
VILLAGE OF NEW LONDON AND DECLARING AN EMERGENCY

BE IT ORDAINED BY THE COUNCIL OF THE VILLAGE OF NEW LONDON, HURON
COUNTY, OHIO, AS FOLLOWS

Section 1. That the Annual Appropriations for the Village of New London, Ohio as reflected in the completed Schedule of Appropriations for 2020 for the Village of New London set forth on Exhibit "A," attached hereto and incorporated herein as if fully rewritten, are hereby adopted and appropriated.

Section 2. The Fiscal Officer is authorized to draw warrants on the Village Treasury for the amounts appropriated in this Ordinance, whenever expenditures are properly presented for which the indebtedness was incurred.

Section 3. That this Ordinance shall take effect at the earliest period allowed by law.
