

ORDINANCE NO. 2021 - 03

AN ORDINANCE AMENDING ORDINANCE 2019-24, SETTING THE 2021 FEES FOR CAMPSITES AT THE NEW LONDON RESERVOIR AND RECREATION PARKS, AND DECLARING AN EMERGENCY

BE IT ORDAINED BY THE COUNCIL OF THE VILLAGE OF NEW LONDON, HURON COUNTY, OHIO, AS FOLLOWS:

Section 1. That Ordinance 2019-24, passed October 14, 2019, be amended, so that, effective beginning with the 2021 camping season, camping facilities at the New London Reservoir or the New London Recreation Park shall be assessed with the following rental fees and terms:

2020 2021 Reservoir & Park Rates and Fees

MUST BE 18 WITH A VALID DRIVERS LICENSE TO CAMP.

50% DEPOSIT DUE AT TIME OF REGISTRATION.

Gate Admission is ~~\$2.00~~ \$3.00 per person. Children 3 and under are FREE

Overnight Guest Fee is \$5.00 per person. Children 3 and under are FREE

Individual Season Pass is \$35.00 per person

Family Season Pass is \$130.00 per a family of five, each addition person is \$20.00 after the 5<sup>th</sup> person.

Special Events is \$10.00 (18 yrs. & up); \$5.00 (4-12 yrs.) \*No Gate Admission Pricing

Dump Station is \$8.00 for non-campers

Propane is \$3.50 per gallon

Stone is \$20.00 per scoop

Return Check Fee is \$15.00 per check

Copies are \$0.10 per sheet

Laundry is ~~\$1.50~~ per load

**WASHER IS \$1.50/LOAD**

**DRYER IS \$1.50/LOAD**

Extra Orange Car tag is \$5.00 per tag

Storage is \$100.00 per unit (car, boat, etc.) per season

Camp Deposit for following year is \$100.00

Firewood by bundle is \$15.00

Firewood by truck load is \$100.00

Firewood \$ 10 pieces is \$5.00

Yearly/Weekend Golf Cart Permits is \$150.00 per year, per golf cart; \$25.00 per night, \$40.00 per two nights, \$75.00 for 6-days WEEK.

Yearly Boat/Kayaks Permit is \$20.00 per boat; \$10.00 each additional boat with the same owner

Daily Boat Permit is \$5.00 per boat

Yearly Windsurf/Kitesurf Permit is \$20.00 per board plus admission; each additional board is \$5.00

Daily Windsurf Permit is \$5.00 per board plus admission

**KAYAK OR BOAT RENTAL IS \$10/HOUR**

Campground Rental is \$200.00 for the day, plus the cost of the shelters/pavilions rented and guest must pay the \$2.00 admission fee at the gate.

Shelter #1 & #4 are \$20.00 per shelter, plus \$2.00 admission fee at the gate or \$150.00 per shelter and that includes all the guest admission fees.

Shelter #2 is \$40.00 per day, plus \$2.00 admission fee at the gate or \$200.00 per day and that includes all the guest admission fees.

Stage/Pavilion is \$50.00 per day, plus \$2.00 admission fee at the gate or \$200.00 per day and that includes all the guest admission fees.

Chapel Rental is 150.00 includes all guest admission. (parking is by chapel in grass area)  
Cabins are ~~\$125.00~~ **\$150.00** a night and hold up to 6 people. \$5.00 for each additional person (after the 6<sup>th</sup> person).

Primitive site is \$25.00 per night, \$150.00 per week, \$400.00 per month or ~~\$1,500.00~~ **\$1,300.00** per season, special event rate is \$40.00 per night, holiday event rate is \$35.00 per night.

Water & Electric sites is \$35.00 per night, \$200.00 per week, \$600 per month or \$1,900.00 per season, special event rate is \$50.00 per night, holiday event rate is \$45.00 per night.

Full Hook-up sites is ~~\$40.00~~ **\$45.00** per night, \$300.00 per week, \$700.00 per month or \$2,000.00 per season, special event rate is \$60.00 per night, holiday event rate is \$55.00 per night.

**RATES ARE BASED ON FOUR PEOPLE, 2 ADULTS AND 2 CHILDREN, ANY ADDITIONAL PEOPLE FOR THE NIGHT IT IS \$5. ANY ADDITIONAL PEOPLE FOR THE SEASON IT IS \$35**

Hileman Building is \$400.00 which includes (\$100.00 security deposit – refundable if cleaned and no damages) night before usage is additional \$50.00

Recreation Park Pavilions are ~~\$30.00~~

**PAVILION RENTAL IS \$30**

**THOMAS PAVILION IS \$75/DAY**

Softball League Fees are \$550.00/team

Softball Tournament Fees are \$200.00/team

**RECREATION PARK - PARK RENTAL FEE IS \$250/DAY**

*\*special events require a 2-night minimum stay.*

*\*50% deposit required to hold reservation*

Section 2. That this Ordinance is hereby declared to be an emergency measure necessary for the immediate preservation of the public health, safety, and welfare of the citizens of the Village and for the further reason that it is necessary to implement the proposed new rates prior to accepting reservations for the coming camping season, and that, provided it receives the majority vote of two-thirds or more of those elected to Council, this Ordinance shall therefore take effect and be in force immediately from and after its passage and approval by the Mayor, and otherwise it shall take effect at the earliest period allowed by law.
