

RESOLUTION NO 15-04

RESOLUTION DESIGNATING CONSTELLATION ENERGY SERVICES, INC. AS THE NATURAL GAS SUPPLIER TO
THE VILLAGE OF NEW LONDON'S GAS AGGREGATION PROGRAM

WHEREAS, Constellation Energy Services, Inc. is certified with the Public Utilities Commission of Ohio as a broker and aggregator; and,

WHEREAS, Constellation Energy Services, Inc. has the necessary expertise to investigate, evaluate and, if warranted, accomplish the required tasks to implement any alternative natural gas supply for the benefit of residential and small business customers of the Village of New London, Huron County, Ohio; and

WHEREAS, the Council of the Village of New London believes it is in the best interests of the Village to authorize Constellation Energy Services, Inc. to act as its Natural Gas supplier for the purpose of providing price stability and price protection and potential savings to residential and small commercial customers of the Village of New London by utilizing an Natural Gas Provider other than Columbia Gas of Ohio[utility] through an opt-out governmental aggregation program in accordance with Revised Code Section 4928.20.

NOW THEREFORE BE IT RESOLVED, by the Council of the Village of New London, Huron County, Ohio, as follows:

SECTION 1.

That the Council of the Village of New London hereby authorizes and appoints Constellation Energy Services, Inc. to act as its agent and Natural Gas supplier for the purpose of providing price stability and price protection and potential savings to residential and small commercial customers of the Village of New London by utilizing an natural gas source other than Columbia Gas of Ohio [utility] through an opt-out governmental aggregation program in accordance with Revised Code Section 4928.20.

SECTION 2.

The Council hereby authorizes the execution of a natural gas supply agreement with Constellation Energy Services, Inc., after the Village of New London Solicitor is satisfied with the terms and conditions of the Agreement.

Section 3.

This Resolution shall become effective at the earliest time permitted by law.

Section 4.

It is hereby found and determined that all formal actions of this Council concerning and relating to the passage of this Resolution were taken in an open meeting of this Council, and that all deliberations of this Council and of any of its committees that resulted in such formal action were taken in meetings open to the public, in compliance with all legal requirements, including Section 121.22 O.R.C.
